1	Demonstrating use of VR set to member of CH Staff (Indoors)	Contracting Covid 19 via surface contact with transfer material. Harm from Covid 19 is known to be a wide spectrum from no/mild symptoms to severe symptoms requiring hospitalisation and, potentially, fatallity.	Care Home staff member	All components required will be presented in a single container (A4 plan size). Items in the container will be sanitised using a propriety antibacterial/viral agent that is effective against a wide spectrum of organisms, including covid-19. This will be carried out by a competent operator who has had 2 covid-19 vaccinations. The container will be sealed and placed in quarantine for a minimum of 7 days.	1	5	5
